RESULT

On the basis of Recruitment test for the Posts of **Assistant Director (Technical) / Principal, Industrial Training Institute Group-A (Junior) in Skill Development and Industrial Training Department, Haryana** conducted by the Haryana Public Service Commission on 11.08.2020, the candidates, **seven times the number of vacancies along with bracketed candidates, if any, bearing the following Roll Nos. are being called for document verification provisionally, subject to the fulfillment of all eligibility conditions. It is made clear that out of the above only eligible candidates three times the number of vacancies in order of merit shall be called for viva voce. It is also made clear that mere being declared successful for the purpose of document verification, the candidates will not be entitled for any right for the said posts. All the representations filed by various candidates regarding wrong questions/ answers for the aforesaid Recruitment Test have been considered and decided finally. 
