On the basis of Recruitment test for the Posts of **Assistant Labour Commissioner in Labour Department, Haryana** conducted by the Haryana Public Service Commission on 27.01.2020, the candidates, three times the number of vacancies alongwith bracketed candidates, if any, bearing the following Roll Nos. have been declared qualified for Viva-Voce provisionally, subject to the fulfillment of all eligibility conditions.
